

Privacy declaration BeauBerger

BeauBerger (hereinafter referred to as: BB) attaches great importance to the protection of personal data. In this Privacy Statement, BB wants to provide clear and transparent information about how it deals with personal data. BB makes every effort to ensure your privacy and therefore handles personal data carefully.

In all cases, BB adheres to the applicable laws and regulations, including the General Data Protection Regulation. This implies that:

- BB processes personal data only in accordance with the purpose for which they were provided;
- these goals and type of personal data are described in this privacy statement;
- processing of personal data is limited to only those data that are minimally required for the purposes for which they are processed;
- BB will ask for explicit permission if it requires it for the processing of your personal data;
- BB has taken appropriate technical and / or organizational measures to ensure the security of personal data;
- BB does not pass on personal data to other parties, unless this is necessary for the purposes for which they were provided;
- BB is aware of the rights regarding personal data, indicates this and respects these.

Wherefore does BB process personal data?

Personal data of (potential) customers and suppliers are processed for the following purposes:

- Include in the customer-supplier administration so that the order can be processed and delivered:
- Recording in the financial administration, sending invoices, newsletters and e-mails interesting to customers;
- Communication about the assignment / quotation;
- Implementing or issuing an assignment / quotation.

For the above purposes, BB can request and store the following personal data of (potential) customers and suppliers:

- Company Name;
- Initials, insert (s), surname and maiden name;
- First Name;
- Titles;
- Full address:
- Phone numbers);
- E-mail address;
- Date of birth:
- Gender.

Provision to third parties

The data that (potential) customers, employees and suppliers give to BB can be provided to third parties if this is necessary for the execution of the above described purposes. For example, she uses a third party for:

- Providing the internet environment of BB;
- Taking care of the (financial) administration;
- Taking care of newsletters and invitations.

BB never transmits personal data to other parties with whom it has not entered into a processor agreement. With these parties (processors), it naturally makes the necessary arrangements to ensure the security of your personal data. BB does not allow the use of personal data for commercial and other advertising purposes.

Furthermore, BB will not provide the information you provide to other parties, unless this is legally required and permitted. An example of this is that the police request (personal) data from BB in the context of an investigation. In such a case, it must cooperate and is therefore obliged to provide this information.

BB can also share personal data with third parties if you give her permission in writing. BB does not provide personal data to parties located outside the EU.

Storage period

BB does not store personal data longer than necessary for the purpose for which it was provided or required by law.

Security

BB has taken appropriate technical and organizational measures to protect your personal data against unlawful processing. For example, BB has taken the following measures:

- All persons who can obtain information from (potential) clients on behalf of BB are obliged to maintain their confidentiality;
- BB uses a username and password policy on all its systems;
- BB pseudonymises and ensures the encryption of personal data if there is reason to do so;
- BB makes backups of the personal data in order to be able to recover these in the event of physical or technical incidents;
- BB regularly tests and evaluates the measures;
- BB employees were informed about the importance of the protection of personal data.

Rights concerning personal data

You have the right to inspect, rectify or delete the personal data that BB has about you. An objection may also be raised against the processing of your personal data (or a part thereof) by BB or one of its processors. You also have the right to have the data provided by you

transferred by BB to yourself or directly to another party if desired. BB can ask for identification before BB can respond to the aforementioned requests.

Complaints

If there is a complaint about the processing of personal data, you can contact BB. You always have the right to file a complaint with the Dutch Data Protection Authority, this is the supervisory authority in the area of privacy.
